2011 Cotton Planting Intentions

In Mid-December 2010, the National Cotton Council distributed the annual early season planting intentions survey. As always, the survey results should be viewed as a measure of growers thoughts and intentions prevailing at the time the survey was conducted. Many changing factors including market conditions, water availability, competing crops prices, weather at planting time, to name a few, could cause final actual number to change significantly from the numbers here which again are based on stated intentions in December 2010 Survey.

CCGGA's initial estimates were 400,000 acres total with pima and upland splits at 250,000 and 150,000 respectively. Today, many in the industry believe that with some of the factors in the mix today; more water and high prices, that the December estimates here could be somewhat higher. Can't disagree! If all the stars continue to stay aligned, with good weather at planting, we could certainly see higher numbers for California cotton!

Landmark Lawsuit Filed: Endangered Species

The Center for Biological Diversity and Pesticide Action Network North America has filed the most comprehensive legal action ever brought under the Endangered Species Act to protect endangered species from pesticides, suing the U.S. Environmental Protection Agency for its failure to consult with federal wildlife agencies regarding the impacts of hundreds of pesticides known to be harmful to more than 200 endangered and threatened species. The lawsuit seeks protection for 214 endangered and threatened species throughout the United States, including the Florida panther, California condor, piping plover, blackfooted ferret, arroyo toad, Indiana bat, bonytail chub and Alabama sturgeon. Over 300 pesticides could be affected.

Association Receives 24c for Temik!



The California Cotton Growers Association has received a third-party Special Local Needs (SLN) 24c

registration for Aldicarb (Temik) valid through December 31, 2014, when Temik's registration will officially end altogether. I became effective on January 24, 2011. Most importantly, the registration allows for the current application rates of 5-7 pounds of product per acre at planting, and up to 14 pounds of product per acre for side dress applications. EPA had proposed to drop side dress application rates to 5 pounds of product per acre, which would

have rendered the chemical useless for most critical situations in California. The Association would also note that the 2014 deadline is also two years beyond what EPA originally told the Association they would allow.

Forklift Rule Update

Have you replaced or retrofitted the remaining 80% of your propane or gas fired forklifts yet. Remember, the California Air Resources Board's (CARB) Large Spark Ignited (LSI) Regulation requires that forklifts



used in crop preparation services, including almond hullers and processors, must have 100% of their fleet in compliance with a 3.0 g NOx/bhp-hr standard by January 1, 2012 as set forth in CCR Title 13. This applies to forklifts that are 1990 or newer, and to facilities that own four or more forklifts. The regulations required 20% of the fleet to be replaced or retrofitted by January 1, 2009. Direct Access Beware

Many of you have called us regarding the option of moving to "Direct Access" for electricity. While it may appear to be great savings on the surface, we hasten to caution folks that many uncertainties remain. First, one of the critical pieces of information that seems to be left out of the communications is the application of an "exit fee". This exit fee can eat up much of the savings proposed by moving to direct access and is applicable to any customer leaving the utility to move to direct access. Be sure to ask your direct access provider what the current exit fee is before making the switch. Second, make sure you understand that moving to direct access is only for the energy portion of the bill or the electricity commodity itself. Distribution and transmission charges (aka demand charges) still apply. These costs constitute approximately 35-45% of the total cost of electricity. The energy prices can be volatile. Make sure you know the length of your contract, as the fluctuation in natural gas prices, the implementation of AB 32 and its fees and required controls will have an impact on energy prices in the future. Also, the implementation of the Renewable Portfolio Standard (RPS) will have a great impact on electricity suppliers, especially those that are substantially deficient in renewable

energy. This could have a huge impact on your electricity prices in the future. Additionally, switching from direct access back to bundled service can only occur at certain times, and may include additional costs, so be sure to have a good understanding of your costs and rights to move back to full PG&E service if you choose to do so in the future. So, while WAPA isn't telling its members not to move to direct access, we would urge every possible caution when considering the switch and make sure you understand all of the consequences before you do.
